



Auto Mécano Contest Rules - “Enter for a chance to win a \$1,500 gift certificate for your next automotive service or repair. ”

1. ELIGIBILITY

Auto Mécano Contest - “**Enter for a chance to win a \$1,500 gift certificate for your next automotive service or repair.**” is open to legal residents of Quebec.

Employees, officers and directors of Vast Auto Distribution Ltée (Auto Mécano) (the “**sponsor**”) and its affiliates, including its parent companies, subsidiaries, related companies, representatives, agents, contest organization agency, advertising and promotion agency and each of their immediate family members (defined as parents, spouses, siblings and children, regardless of where they live) and those with whom they reside (whether or not they are members of their immediate family) are not eligible.

2. CONTEST PERIOD

The contest begins on May 1, 2026, at 9:00 a.m., ET, and ends on October 1, 2026, at 11:59 p.m., ET (the “**contest period**”). The sponsor’s computer server is the sole determinant of the date and time of receipt of an entry and is the official timekeeping device for this contest.

3. ENTRY

No purchase necessary. Participants across Quebec are invited to enter via the registration form on the Auto Mécano website (<https://automecano.ca/newsletter-contest-autumn/>).

To enter the contest, you must:

- a) Fill out the newsletter registration form on the Auto Mécano website (<https://automecano.ca/newsletter-contest-autumn/>) and provide your last

name, first name, telephone number and email address (the “personal Information”).

b) Like Auto Mécano’s Facebook page.

c) Agree to the contest rules available online and agree to abide by them.

d) Be 18 years of age or older.

Participants may register only once. The participant may win only one prize, i.e., **one (1) automotive service or repair of a maximum value of \$1,500**, and this prize is non-transferable. Anyone who has accumulated more entries than the limit of one permitted entry will be disqualified and all entries received from that person during the contest period will be void.

Entries that are late, lost, stolen, ineligible, contain erroneous or incomplete information, have been submitted improperly or do not comply with the terms and conditions of these rules will be voided. All entries become the property of the sponsor upon receipt and will not be returned. The sponsor is not responsible for lost, late, illegible, incomplete or misnamed entries.

4. PRIZE

There is one (1) available prize comprised of an automotive service or repair worth up to \$1,500. Odds of winning this prize depend on the number of entries received during the contest period.

The prize must be accepted as is and may not be transferred, sold, given away, assigned or exchanged. The prize may be different from that shown in the contest publicity or promotional material. The sponsor reserves the right to substitute any prize with one of equal or greater value in the event it is unavailable for any reason. All expenses, taxes and costs related to the acceptance and use of a prize that are not mentioned in these rules are the responsibility of the winners.

5. WINNER SELECTION

The prize will be awarded by random draw from among all eligible entries received.

The draw will take place on October 1, 2026, at 9:00 a.m. (ET).

The selected participant will be contacted by email and/or telephone within ten business days of the draw date. To be declared a winner, the selected participant must:

- a) Register for the Auto Mécano contest and newsletter by filling out the registration form on the Auto Mécano website (<https://automecano.ca/newsletter-contest-autumn/>) and have liked the Auto Mécano Facebook page.
- b) Sign and return a Declaration, waiver, release and publicity consent form confirming compliance with the contest rules and releasing the sponsor, its employees, representatives, agents, advertising and promotional agencies, affiliates, directors, officers, shareholders, partners, subcontractors, agents, distributors, successors and assigns (collectively, the “representatives”) from any liability regarding prizes won (the “Declaration”) within five (5) days of notification of prize win.

No other use or disclosure of personal information will be made by the sponsor unless consented to in the registration form. - c) Consent to the collection of their personal information by the sponsor for the purposes set out above.

7. LIMITATION OF LIABILITY

By entering this contest, participants release the sponsor and its representatives from any and all liability for death, injury or damage of any kind (including direct, indirect, special or punitive damages) to any person

or property resulting from (a) the prize, including acceptance of, participation in, misuse or abuse of, or addictive or counteractive use of, the prize or its use in an inappropriate circumstance; (b) participation in this contest, including access to and use of Auto Mécano's Facebook page, and any claim based on personality rights, personal information, right to privacy or defamation.

By accepting the prize, the winner consents to the use of his/her name, personal information and/or image and photograph by the sponsor or its agents for advertising and promotional purposes relating to this contest in any media or form whatsoever without further notice or compensation.

All participants whose entry forms are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or who have not complied with these rules may be disqualified by the sponsor. The sponsor is not responsible for lost, stolen, delayed, damaged, misdirected or destroyed entry forms or for typographical or other errors.

The sponsor cannot be held responsible for any outage related to the Internet service, www.facebook.com website, telephone network, computer online systems, servers, Internet access providers, computer equipment, software, or any injury or damage to the participant's or any other person's computer related to or resulting from participating or downloading any materials included in this contest.
